**10. PLAY AREAS**

Queen Street Play Area –Treuddyn. Proposed ‘Small Wheel Play’ a letter from Bendcrete Skate Parks confirming they are costing the design. The Clerk has forwarded the design option;

they have also received a map of the playing field marking where the park is to be installed.  
With reference to the Matchfunding 2022/23 there is a total of £20,000 (£10,000 FCC & £10,000 TCC)  
It was agreed the Keep Fit apparatus on the Queen Street play area requires upgrading. The clerk to request a catalogue from Mr Richard Roberts–Play Design Officer.
